 3. Proposed structural woodland planting to be protected with temporary fencing and spiral guards to ensure successful establishment.
 4. Some tree positions may have to be amended to accommodate any amendments to locations of services.
 5. Sports pitch treatment by others.
 6. For information on surface materials & details of hard landscape features such as walls & fences refer to architect's drawings.
 7. For information on levels & drainage refer to engineer's drawings.
 8. Limited information with regard to levels, drainage & underground services was available to us at time of preparation of drawing.
